NOTICE TO BIDDERS

The Erie County Water Authority will receive separate, sealed bids for the furnishing of all labor, plant, tools, equipment and specified materials or services for **WTP Residuals/Sludge Removal, Disposal, and Relocation at the Sturgeon Point Water Treatment Plant**. The Work consists of removal, disposal, and relocation of water treatment plant residuals/sludge, within on-site lagoons, that has been removed from water treatment plant processes (filter backwash and coagulation basin blowdowns) located in Erie County Water Authority's Sturgeon Point Water Treatment Plant (WTP).

Bids must be received by the Erie County Water Authority no later than 10:00 a.m. Eastern Prevailing Time, on Friday, August 19, 2022 at the Service Center Front Desk, Erie County Water Authority, 3030 Union Road, Cheektowaga, New York 14227.

When permitted, members of the public may be present to observe the bid opening. All attendees must bring a government-issued photo identification (driver's license preferred) and check-in with the ECWA receptionist before being allowed entry to the bid opening.

Whenever the Erie County Water Authority is operating under a Declaration of Emergency due to a pandemic or other general state of emergencies, members of the public may be precluded from being present at such bid opening.

ANYONE ENTERING THE SERVICE CENTER OR OTHER AUTHORITY FACILITIES IS SUBJECT TO SUCH RESTRICTIONS OR LIMITATIONS IN PLACE AT THE TIME OF ENTRY.

All bids being mailed (including FedEx, UPS, Priority Mail, etc.) or delivered shall be directed to the "SERVICE CENTER FRONT DESK" at the address listed above in a sealed envelope and be clearly marked on the outside of the mailing or hand-delivered envelope "BID ENCLOSED-ECWA Project No. 202200111, Sturgeon Point WTP Residuals/Sludge Removal, Disposal, and Relocation".

Beginning at 9:00 a.m. Eastern Prevailing Time, on Friday, July 29, 2022, Project Manuals and accompanying drawings, if applicable, may be obtained by writing the Service Center Front Desk at the above address or calling 716-684-1510, between the hours of 9:00 a.m. and 4:00 p.m. Contract Documents will be mailed to prospective bidders wishing to obtain a set upon receipt of prospective bidder's charge number for UPS or FedEx. The mailing date will be considered the bidder's date of receipt. Partial sets of documents will not be available.

A pre-bid meeting will be held at 9:00 a.m., prevailing time, on Friday, August 5, 2022, at the Sturgeon Point Water Treatment Plant (722 Sturgeon Point Road, Derby, New York 14047).

Attendance at the pre-bid meeting is recommended but is not mandatory. All attendees must bring a government-issued photo identification (driver's license preferred) and check-in with the ECWA receptionist before being allowed entry to the pre-bid meeting.

Each bid shall be accompanied by a certified check or bid bond in the amount of five percent (5%) of the amount of the bid.

In accordance with State Finance Law §§139-j and 139-k, all questions about meaning or intent of the bidding documents shall be submitted to the designated contact person in writing.
