A) SECRETARY

Secretary McCracken noted he has nothing to report, however, he informed the Board that item 16 on today's agenda will need to be amended. Karen Prendergast will speak to that when we approach the item.

B) LEGAL

1. 2020 FOIL Audit

General Counsel Murphy remarked that the Legal department is responsible for conducting an audit on FOILS that were submitted for the previous calendar year. She said that this came close to being a perfect year except for one FOIL. The initial response letter was sent one day after the due date. The final response with requested documents was, however, timely sent. The Office of the Secretary did not receive a single FOIL request from any member of the media. Instead, the Secretary responded to any media inquiry without demanding the filing of a FOIL request. Since no one was denied access to any public record, no appeals were filed with the Board of Commissioners. Vice Chairman Carney commended Ms. Murphy on a job well done. Ms. Murphy added that credit belongs to the Office of the Secretary. Chairman Schad noted that this is a good example where the will to do it right can make it all happen.

2. Executive Session

Executive Session was deferred to the end of the meeting.

C) FISCAL

1. GFOA's Certificate of Achievement Award

Karen Prendergast informed the Board that the Government Financial Officers Association (GFOA) has awarded the Authority their certificate of Achievement for Excellence in Financial Reporting for the Authority's 2019 Comprehensive Annual Financial Report (CAFR). This is the 15th year that the Authority has submitted and been awarded the certificate. She added that the preparation of the CAFR is a joint effort by the entire Finance department with the assistance of the Authority's independent auditors. Ms. Prendergast intends to prepare and submit a CAFR for 2020 to the GFOA for consideration in May of 2021.

2. 2020 Unaudited Financial Statements

Karen Prendergast reported that §1070 of the Authority's enabling statute requires the Authority to submit to the Erie County Legislature and the Erie County Comptroller, within the first month of each fiscal year, a detailed report of operations and fiscal transactions of the authority during the preceding fiscal year, the financial condition of the Authority, and a statement of all receipts and expenditures during the year. She added that she intends to comply with the requirement, although she does not have the unaudited financial statements prepared for this meeting. She will distribute a copy of the unaudited financial statements to the Board when they are given to the county and New York State.

D) OPERATIONS

1. RFP - Transmission Main Design Projects 2021-2022 (Contracts A, B, and C)

Executive Engineer Kowalski informed the Board that the Authority recently issued a Request for Proposal (RFP) to eight consulting engineering firms for transmission main design projects 2021-2022 in which six firms responded. The RFP was also posted to the Authority's website in which five firms submitted proposals. Mr. Kowalski explained that these projects are separated into three different contracts (Contracts A, B, and C). If there are no objections, the Engineering Department would like to move forward with negotiations with Nussbaumer & Clarke (Contract A), Greenman Pedersen (Contract B) and Erdman Anthony (Contract C) to develop contracts for the referenced projects. Vice Chairman noted that it is nice to see more firms bidding.

2. RFP - Distribution Main Design Projects 2021-2022 (Contracts A, B, C, D, E and F)

Executive Engineer Kowalski informed the Board that the Authority recently issued a Request for Proposal (RFP) to 11 consulting engineering firms for distribution main design projects 2021-2022 in which all firms responded. The RFP was also posted to the

Authority's website in which two firms submitted proposals. Mr. Kowalski explained that these projects are separated into six different contracts (Contracts A, B, C, D, E and F). If there are no objections, the Engineering Department would like to move forward with negotiations with LaBella Associates (Contract A), CHA Consulting (Contract B), Barton & Laguidice (Contract C), William Schutt & Associates (Contract D), DiDonato Associates (Contract E) and Wendel (Contract F) to develop contracts for the referenced projects. Chairman Schad asked Mr. Kowalski if these are all projects where we will do the construction in 2022. Mr. Kowalski replied that is correct.

3. Washwater Tank Replacement Sturgeon Point Water Treatment Plant

Executive Engineer Kowalski reported to the Board that the Sturgeon Point Water Treatment Plant utilizes a 500,000-gallon elevated steel washwater tank as the source of water to backwash the filter switch is in need of repair of repair and rehabilitation. Staff has been trying to develop a plan on how to handle that over the last couple of years. This has been included as a task in the MP 85 contract. The consultant looked at nine different alternatives, and basically determined that the best solution is to build a brand-new concrete tank and then take the existing one out of service. The current tank cannot be taken out of service long enough to paint it. Mr. Kowalski explained to Vice Chairman Carney that the new tank will be built in the vicinity of the old tank. Mr. Carney asked if while building and designing the new tank if the problems with the old tank are being taken into consideration so the same problems do not reoccur 25 or 30 years from now. Mr. Kowalski noted that the problem with the old tank is that it is steel, and with steel the rehab cycle is going to be the 25 to 30 years. With concrete there is a much longer life and reconditioning is not needed. Commissioner LaGree asked if he was taking into consideration investing additional funds to rehab to act as a redundant as a washwater source. He responded that after further discussions they weren't going to go that route. Chairman Schad added that the Authority has gotten by with one tank for many years, however he questioned if there was any alternative that would give us redundancy. Mr. Kowalski replied that what we plan on having is some additional risers put on the interconnection that we could then connect to in case there was an emergency. We would have to rent pumps to make that happen. So, there's going to be the balance between having that interconnection point and the ability to rent pumps to backwash Filters versus rehabbing the existing tank for \$1.5 million to \$2 million. We can definitely look at what that risk is versus costs in the future to rent pumps versus rehab costs. Chairman Schad would like to have the engineering assessment done. Mr. Kowalski said he will make sure the RFP will incorporate looking into that.
