1. Material Inventory for Water Service Lines Lead & Copper Rule

Russell Stoll reported there are proposed new USEPA regulations regarding lead and copper service lines found in water systems. This new rule will require a material inventory of water service lines in the water distribution systems. Chairman Schad had a concern that we are making sure we are collecting the information we should for lead and copper lines to meet this new requirement that will be put upon us at some point once the rule is finalized. Mr. Stoll distributed a memo providing a description of the current status of the Authority lead service line inventory procedure. He explained that we do have a system in place. All data that is collected from various sources is entered into the IBM Power System or in the Cityworks information data base line and joined together as a single data base. This data then resides in the Geographic Information System data base as well as the IBM Power System data base. Chairman Schad noted the other concern he had was knowing the magnitude whether it's very small or very large of how much more work we have to do to know what is where when it comes to lead. Is there a way to do a follow-up on this that would give us a picture of the area we serve and where we have complete information, where we have partial information and where we have no information? Mr. Stoll added that the goal would be to have a map that shows everything. He would like to come back with a map or something graphic that would be helpful.

Daniel NeMoyer distributed a memo relative to the RFP for Administration of Employee Flexible Spending Accounts Under IRC Section 105(h), Section 125 and Section 132(f). Six RFPs were sent out and three responded. He reported that P&A Administrators were considerably cheaper than the others on a monthly per person basis. They also do not have annual fees and minimum monthly that the others do. They have provided good work for us in the past. Mr. NeMoyer would like to negotiate a contract with P&A and come back at a future meeting. This was approved by the Board.

Mr. Kowalski explained that Contract WSA-13 is a large valve replacement contract. While the contractor was in the process of checking valves to replace one of them, the Authority had a watermain break not far from the Wehrle tank

so that delayed the contractor in changing the one valve out. While we were in the process of making the repair near the blue water tower, they got that repair completed using our emergency repair contractor. As we went to the turn the water back on and start filling the main, the main was taking longer than usual to fill. What had happened at that point was the main underneath Main St. right of the 290 had ruptured. The contractor was already working in that area for another large valve replacement, so we tied in the work as a change order. Commissioner Jones noted that they had to proceed under irregular procedures to get this work done, and that is why we are treating this as a change order along with amendment for the engineering services. Mr. Kowalski noted that it came down to a public safety matter. Chairman Schad reiterated that this was a necessary emergency declaration because that rupture emptied the Wehrle tank.
