# 1. RFP Comprehensive Facilities Plan

Mr. Stoll reported that five firms submitted proposals for the Comprehensive Facilities Plan RFP. After a review of the proposals, four firms were invited for follow-up interviews which included a discussion of the related experience of each firm. It was decided to retain Clark Patterson Lee for the project. Mr. Stoll requested permission to negotiate a contract with Clark Patterson Lee and bring back to the Board for approval. Chairman Schad asked what was the anticipated time that they would have a product for the Commissioners. Mr. Stoll said it would take about six months. Vice Chairman Carney inquired if the Authority has to authorize the release of information that they can review. Ms. Murphy noted that there may be some information regarding access to facilities and security. Vice Chairman Carney asked that there be a confidentiality agreement.

## 2. Customer Letter

Mr. Stoll distributed a letter from a City of Tonawanda customer expressing her satisfaction for the work performed and response time for a repair that was made on her property.

# 3. Memo - Water Quality Testing

Ms. Figler distributed a memo updating the Commissioners relative to the use of outside laboratories to perform EPA and NYSDOH required monitoring. She reported that the series of events that have occurred these past two quarters further supports the decision to purchase the analytical equipment in addition to a TOC analysis. She noted that last quarter Test America did not perform six out of 21 samples during the hold time according to the method, therefore, she feels they should not be paid. Chairman Schad concurred, at least until we are comfortable in our position. Mr. Jones asked what the amount is owed and if there is anything in the contract that defines this. Ms. Figler replied no that it is only a purchase order. It was explained that this work will all be performed in-house in 2020 except the first quarter. She noted that it will cost more performing the work in-house versus outsourcing. Chairman Schad remarked that he is in agreement with having this in-house, as the reliability is more important. Vice Chairman Carney concurred. Mr. Carney recommending paying Test America. Karen Prendergast suggested looking into what was required when we made the purchase along with insurance requirements.

## 4. Ball Station Emergency Declaration

Executive Engineer Kowalski reported that on December 18, 2019 an emergency condition at Ball Pump Station was declared. He explained that a Pump Mechanic was investigating a high-water alarm at the northern venturi chamber and noticed the piping in the chamber was out of alignment. Ball Pump Station is a critical pump station for delivering water to our northern service area, and we need to ensure that the station stays in service. Mr. Kowalski explained that bypass piping will be installed on the northern and southern sides of the station. The bypass piping will allow the Authority to keep the plant operational if there is a failure on the eastern side of the discharge piping. He would like to use one of our existing contractors who is experienced with this type of work especially with the concrete pipe. A work change directive will be prepared and followed up with a change order. Commissioner Jones asked if there were any plans for inspection of the underground facility. Mr. Kowalski replied that the bypass piping will be installed then we will design for the full replacement of the piping outside the venturi pipes over the next two years.
