1. RFP For Banking Services

Karen Prendergast reported that it has been ten years since RFPs were issued for banking services. Since the banking environment continues to change and may become more competitive with anticipated changes to Federal Reserve policy, Ms. Prendergast feels this is a good time to issue an RFP for banking services. She added that there is a resolution on the agenda for approval.

Karen Prendergast distributed the December Investment Report along with a brief explanation of the report.

3. Monthly Financial Report – December 2021

Joyce Tomaka distributed the December 2021 Monthly Financial report which includes operating revenue, investment income, operating expense and net income, and briefly reviewed the data. Chair Schad inquired of CFO Prendergast about the electrical expense for 2020. Ms. Prendergast indicated that electricity, although relatively stable, the Authority did experience a rise in the pricing.

1. RFP Sturgeon Point Water Treatment Plant Shoreline Protection Project

Leonard Kowalski reported that a Request for Proposal (RFP 202100253) was recently issued for consulting engineering services for the design and construction of improvements to the shoreline and existing outfall headwall at the Sturgeon Point Water Treatment Plant. RFPs were issued to eight consulting engineers, and three other firms obtained the RFP through the posting on our website. Five firms chose to submit proposals for this project. The proposals were reviewed and discussed among the engineering staff, and it was determined that GZA GeoEnvironmental of New York was the best suited for the project. In order to expedite this project, the Engineering Department will be requesting approval of the Services Agreement with GZA GeoEnvironmental of New York at today's meeting. Commissioner Iannello inquired about the scope of the shoreline work and Executive Engineer discussed the breath of the erosion problem.

2. RFP Water System Improvements Town of Amherst Distribution System 2022-2024

Leonard Kowalski reported that a Request for Proposals (RFP) was recently for engineering services for design and construction phase services to replace several distribution mains in the Town of Amherst. The RFP was issued to eleven consulting engineering firms and posted to the Authority website. Six of the original firms responded did not submit proposals. Additionally, Michael Baker International submitted their proposal based on Authority's website. The proposals were reviewed and discussed among the engineering staff, and it was determined that Nussbaumer & Clarke, Inc. In order to expedite this project, the Engineering Department will be requesting approval of the Services Agreement with Nussbaumer and Clarke, Inc. (Contract NC-044) at today's meeting.

3. RFP Water System Improvements, Union Road Corridor System, Towns of West Seneca and Cheektowaga

Leonard Kowalski reported that a Request for Proposals (RFP) was recently for engineering services for services for design and construction phase services to replace several sections of mains within the Union Road Corridor distribution system in the Towns of West Seneca and Cheektowaga design and construction phase services to replace several distribution mains in the Town of Amherst. The RFP was issued to twelve consulting engineering firms and the RFP was also posted to the Authority website. Eight of the original firms responded. Additionally, Clark Patterson Lee (CPL) submitted their proposal based on Authority's website. The proposals were reviewed and discussed among the engineering staff, and it was determined that Greenman-Pedersen, Inc. was the best firm for this project. In order to expedite this project, the Engineering Department will be requesting approval of a Service Agreement with Greenman-Pedersen, Inc. at today's meeting.

4. RFP Distribution Main Design and Projects 2022-2023

Mr. Kowalski reported that a Request for Proposals (RFP) was recently issued to eleven consulting engineering firms for engineering services for design and construction phase

services for several distribution main projects in various locations within the ECWA direct service area. The RFP was also posted to the Authority website. These projects are separated into five different contracts (Contracts A, B, C, D, and E). Of the original firms, ten chose to submit proposals. In addition, four other firms submitted proposals based on Authority's website. The proposals were reviewed and discussed among the engineering staff, and it was determined that project be split among Barton & Longuidice, DPC, DiDonato Associates, Wm. Schutt & Associates, LaBella Associates and Watts Architecture & Engineering. In order to expedite these projects, the Engineering Department will be requesting approval of the individual Professional Services Agreements with each firm at the February 10th meeting.
