1. Actuarial Valuation of Other Post-Employment Benefits (OPEB)

Karen Prendergast gave a brief update on the report submitted by Benefit Plans Administrative Services, Inc. (BPAS) in compliance with Government Accounting Standards Board (GASB) Statement 75 — Accounting and Financial Reporting for Postemployment Benefits Other Than Pensions (OPEB).

Ms. Prendergast explained that the Authority is required to account for its commitment to provide health insurance to employees in retirement. Health insurance benefits are provided to retirees meeting the eligibility requirements based on policy or the applicable collective bargaining agreement. Ms. Prendergast remarked that for the year ended December 31, 2020, the Authority's liability was calculated at \$89,032,011, as compared to \$90,082,536 in 2019 – a decrease of \$1,050,525.
