ITEM 3 - AUTHORIZATION TO ENTER INTO A LEASE MANAGEMENT AGREEMENT WITH THE TOWN OF ORCHARD PARK

WHEREAS, the Erie County Water Authority (the "Authority") entered into an Agreement with the Town Board of the Town of Orchard Park ("Town") acting as Water Commissioners for the Town of Orchard Park for Water District Nos. 1, 2, 3, 3-1, 3-2, 3-3, 4, 4-1, 6, 6-1, 6-2, 6-3, 6-4, 6-5, 7, 8, 8-1, 8-2, 8-3, 8-4, 9, 9-1, 9-2, 9-3, 9-4, 10, 11, 12, 13, 13-1, 14, 15, 17, 17-1, 17-2, 17-3, 18, 19, 19-1, 20, and 21 (the "District") for the sale and distribution of water to the customers in said district, whereby the Authority agreed to manage and operate said district, which by said agreement was leased to the Authority for that purpose, treating each of the customers therein as retail customers and charging the customers therein for the sale of water the same rates and charges as are imposed on other customers throughout the Authority's territory not under lease management; and

WHEREAS, in accordance with a lease management agreement, executed on September 2, 1998 between the Authority and the District, and as amended on December 5, 2002 and on November 6, 2003, the Authority has been providing water services to the domestic, commercial, industrial and agricultural water customers, using the water facilities owned by the Town of Orchard Park and leased to the Authority, or owned by the Authority, within the areas designated as the Town of Orchard Park Water District Nos. 1, 2, 3, 3-1, 3-2, 3-3, 4, 4-1, 6, 6-1, 6-2, 6-3, 6-4, 6-5, 7, 8, 8-1, 8-2, 8-3, 8-4, 9, 9-1, 9-2, 9-3, 9-4, 10, 11, 12, 13, 13-1, 14, 15, 17, 17-1, 17-2, 17-3, 18, 19, 19-1, 20, and 21; and

WHEREAS, the parties find it mutually advantageous for the Authority to furnish a supply of water to the District and to operate and manage the District's facilities;

WHEREAS, the Authority submitted a new agreement to the Town offering to extend service to the Town under the terms and conditions contained in the new Agreement; and

WHEREAS, the term of this Agreement shall be for a period of ten (10) years from the date hereof and for successive ten-year periods thereafter unless a notice of intent to renegotiate or terminate said Agreement is given by one party to the other within one year prior to the expiration of one of the ten-year periods; and
