WHEREAS, the Legislation also mandates annual cybersecurity awareness training for government employees across New York and sets data protection standards for state-maintained information systems; and

WHEREAS, the enactment of the Legislation underscores New York State's commitment to cybersecurity, setting a precedent for other states to follow in protecting both state and local critical infrastructure from cyber threats;
