#### 1. Projects Advertised for Bidding – Formal Contracts

Mr. Stoll informed the Board of projects that have been advertised since the last Board meeting: Asbestos Cement Pipe (ACP) and Asbestos Containing Materials (ACM) Abatement, Removal, and Disposal, June 1, 2023 through May 31, 2025, Sheridan Drive Water System Improvements, Town of Amherst, Water Distribution System Replacements and Improvements Contract, May 1, 2023 to April 30, 2025 and Contract JMD-001, Water System Improvements, Hamburg, Cheektowaga, West Seneca, and Depew.

#### 2. Project Advertised for Bidding – Short Form Contract

Mr. Stoll informed the Board of one project that has been advertised since the last Board meeting: Furnish and Deliver Liquid Chlorine in One Ton Containers to the ECWA for Use in the Treatment of Water for Four Months.

#### 3. Final Payment Application

Mr. Stoll reported to the Board that there have been two final payments processed since the last board meeting: Contract EA-012, Water System Improvements, Towns of Cheektowaga and West Seneca and Village of Depew, PN 202000065, and Contract GP-009, Water System Improvements, PN 202000079

#### 4. RFP Recommendation

Mr. Stoll informed the Board that the Authority recently issued a Request for Proposals for engineering services for the refurbishment of eight water storage tanks within the Authority's system. The RFP was sent to five consulting engineers and was also posted to the ECWA website which resulted in interest from one additional firm. Only one firm chose to submit a proposal for this project, Wendel. The proposal was reviewed and discussed among the

engineering staff, and it was determined that Wendel possesses the relevant qualifications to perform the proposed work. Engineering will proceed with negotiating a professional services agreement.

#### 5. ECWA Operations Center

Mr. Stoll informed the Board that the Authority recently issued a Request for Proposals for engineering and architectural consulting services for the design and construction of the new ECWA Operations Center. The RFP was sent to seven firms and was also posted to the ECWA website which resulted in interest from an additional four firms. Seven firms chose to submit proposals for this project. After a review of the proposals, it was determined that Labella Associates is best suited for the project. Engineering will proceed with negotiating a professional services agreement.

#### 6. Board Request for Service Line Inspection Incentive

Sabrina Figler, Director of Water Quality, spoke regarding the EPA Lead and Copper Rule (LCR). Ms. Figler explained that LCR Standard Monitoring requires the sampling of 100 Tier One sites every six months. Fifty of the 100 sites are required to be homes with a lead service line. To incentivize customers to allow access to their homes and receive the samples before the deadline of June 30, 2023, Ms. Figler requests the Board offers a \$25 bill credit to customers who allow access to their homes to perform an in-home inspection to confirm material type at the meter and commit to the sampling or field verifications for the lead service line.

#### 1. AED & Hands Only CPR Training

Jennifer Hibit reported to the Board that AED and Hands Only CPR training was given to 131 ECWA employees at the Service Center on February 28 and March 1, 2023. Training for employees at the Ellicott Square Building and both plant locations are in the process of being scheduled.

#### 2. Employee Assistance Program RFP

Ms. Hibit notified the Board that the Authority's professional service agreement with Child and Family Services for ECWA's Employee Assistance Program expires on April 30, 2023, with all renewal options exhausted. Therefore, the Authority issued a new RFP for an Employee Assistance Program. Ms. Hibit plans to have a resolution on the April 20, 2023 Board meeting to enter into a professional services agreement for these services.
