#### 2. Monthly Financial Report – February 2022

Joyce Tomaka distributed the February 2022 Monthly Financial report which includes operating revenue, investment income, operating expense and net income, and briefly reviewed the data. She noted that there was an error on the report made when posting the payments to contractors. \$180,000 for excavations was incorrectly posted to the contractors on the electrician line rather than the repairs. So, the proper presentation should show actual of \$560,000 and be under budget of \$166,000 for payments to contractors and then repairs line should show actual of \$449,000 as opposed to \$269,000. It is higher than budget by \$18,000.
