 - 1. Procurement Error Saia Communications

Lichtenthal

Mr. Lichtenthal distributed a memo for the Commissioners' review. He advised that this was emergency work performed to keep up the microwave link and communications between Van de Water raw water and the treatment plant. He further advised there is an outstanding bill due at this time. If all is in order, there will be a purchase order on this at the next meeting. Ms. Murphy advised that she is drafting the new procurement guidelines that will reflect more defined guidelines relating to declarations of emergencies and this will then be brought to the Board for review and approvals.

2. Procurement Error – Ledge Creek Development

Lichtenthal

Mr. Lichtenthal distributed a memo for the Commissioners' review. He advised that this did not follow in "past practice" with what should be a proper practice, but the result is that this vendor is not being paid because the Authority cannot put up a purchase order without discussing with the Board. Mr. Jones requested Legal to review this.

3. Emergency Declarations

Lichtenthal

Mr. Lichtenthal distributed three declaration of emergencies for the Commissioners' review. Ms. Murphy added that these declarations should be close in time to the emergency, not three months later. She advised there will be procedures regarding these matters in the procurement guidelines. Mr. Carney advised he would like to get notified of any emergency declaration when it occurs.

4. RFP Waterline Replacement Projects 2019-2020

Stoll

Mr. Stoll distributed a memo regarding an RFP that was sent out to ten firms for various waterline replacement projects. The proposals received were separated into six contracts which engineering review and broke into groups as indicated on the memo. He requested Board approval to move forward to negotiate agreements with the various firms. Mr. Schad asked for clarification on Item D as to why this is on hold and Mr. Stoll advised that it was adding a watermain on Greiner Road, but more information was needed before the Authority makes any decisions on this project. He advised that this project is for water capacity only.

Mr. Carney inquired if there was any advantage to going to the firms and offering them multiple projects and return for a reduction in price. He suggested perhaps modifying future RFP's to reflect language regarding this.

Mr. Schad added there is an advantage to using multiple vendors to not be sole-source dependent. Mr. Lichtenthal advised the theory is the work needs to be complete by November 2019 to meet the 2020 budget and that if one firm received all the business and for some reason that firm loses its capacity, the Authority's capital plan would be impacted. Mr. Carney feels that the legal department, engineering department and financial department are tasked with doing more work with all the different firms.

Ms. Murphy suggested adding language to the RFPs indicating that if a firm submits multiple proposals for projects that the Authority leaves itself open to negotiate a better price if the firm receives multiple contracts.

There were also discussions about providing the fire departments with GPS methods to have immediate knowledge of capacity of the lines. Mr. Carney feels that the fire districts should come up with what they feel would work for them and the Authority will work with them.

Mr. Jones agreed with Mr. Carney as there are multiple fire districts in the different communities that do things differently. He suggested that the Authority supplies the information to the numerous fire departments in the communities and they can use to their advantage as to what works for each individual fire department, whether it be paint, a badge, etc.

Mr. Carney advised that whatever solutions the fire departments come up with, the Authority will grant permission to mark the hydrants to their benefit.

Mr. Carney noted for the record that he feels this resolution makes is sound that the Authority did something wrong, which it did not. Ms. Murphy indicated that the legislature is not well informed, but if the engineering department communicates this, there might be a better understanding.
