D. OPERATIONS

1. Contract No. CH-012

Mr. Kowalski reported that back in Contract No. CH-010, Water System Improvements in the Town of Cheektowaga was awarded to DJM Contracting, Inc. This project was anticipated to be completed in 2020, however there were some delays associated with the project there were out of the contractor's control, but there were also inefficiencies on behalf of the contractor that also contributed to additional delays. The Engineering and Legal Departments are currently reviewing the documentation provided by CHA to determine whether DJM should be held responsible for costs associated with its inefficiencies. At this point our goal is to negotiate a settlement with the contractor, including a contract extension as well as any applicable portion of the additional resident inspection fees, and to complete the Project. In addition, following completion of the work, an amendment will also be prepared for the additional consulting fees which must be paid by the Authority regardless of the outcome of the negotiations with the contractor. Ms. LaGree asked if this is typical of DJM. Mr. Kowalski replied that they are somewhat of an inefficient contractor with the way they perform their work. She remarked that this should be noted for the future. Mr. Schad concurred with Commissioner LaGree and added that the Authority needs contractors that we can rely on in terms of efficiency.

A brief discussion was then held regarding if the Authority could preclude them from future use.

2. May 2021 Capital Budget Update

Leonard Kowalski reviewed with the Commissioners the capital budget update he previously provided. Chairman Schad inquired as to which areas does the Authority have its redundancy issues, along with what other solutions are there to get past these easement issues to get whatever consensus we need? He added that the last thing we need is one of the critical transmission lines where we think we need to get this done sooner than later to be one of the ones that ended up failing on us. It would be nice to see those at the 95% range by the end of the year. He asked Engineering if they could try to find a way to move it even faster. He would like to see to get to a higher percentage by year end, if possible. Ms. LaGree expressed her appreciation for this update.

3. Hancock Tank Study – City of Buffalo

Over the past several months, the Authority has been in communication with the City of Buffalo Division of Water about another large interconnection with the Authority and the City. We currently have one interconnection that feeds our Pine Hill Pump station. During emergencies or periods of high demand in the summertime, the Authority uses that connection a lot. He added that the City has hired a consultant to conduct a preliminary hydraulic study and they identified another possible interconnection, at their Hancock tower, which is in South Buffalo. The Engineering department plans on pursuing a cooperative agreement with the City. For the additional hydraulic analysis that is required, the City can select a consultant as part of their standard procurement process, which they are proposing to use Nussbaumer and Clarke. Mr. Kowalski added that they've done a lot of hydraulic modeling for the City and they are very familiar with the Authority's distribution system to. Mr. Schad asked what is the timing on this

What do you see is the timing on this, that is, if this goes forward, when would we see the results of a study? Mr. Kowalski replied that he believes they would be able to wrap this up by first quarter of 22 would be my guess.
