# Banking RFP

Karen Prendergast advised the Board that an RFP was recently issued for Banking Services. Responses were received from KeyBank, M&T Bank, JP Morgan Chase and Bank of America. After a review, Ms. Prendergast recommended the Authority maintain its banking relationships with M&T as the current trustee for the Authority's debt service accounts and Key Bank as the lockbox and ACH provider. Commissioner LaGree asked if the Authority will have to renegotiate. Ms. Prendergast replied that she doesn't foresee any changes with Key Bank or M&T. Ms. Prendergast explained the deposit credit analysis that is conducted monthly. She noted that is not a contract - it's a choice the Authority makes as they will give us credit for money we keep on hand in the checking account because it is interest free in lieu of interest.

# **D. OPERATIONS**

# 1. EPA Lead & Copper Rule Revisions

Leonard Kowalski reported to the Board that an RFP was recently issued for the development and implementation of a compliance program for EPA's Lead and Copper Rule Revisions (LCRR) with the Consultant acting as the Program Manager. Under this project, the Program Manager will take on the administrative role of coordinating the ECWA's response to the LCRR. Arcadis of New York, Inc. (Arcadis), GHD, and Hazen & Sawyer submitted proposals. Two additional firms, Blue Conduit and 120Water chose to offer subconsultant services to the prime consulting firms. After the proposals were reviewed and discussed among the engineering and water quality staff, it was determined that Arcadis of New York is the best firm suited for the project. Mr. Kowalski informed the Commissioners that the lump sum cost for the services is approximately \$570,000. There will be resident inspection costs in the approximate amount of \$60,000 for work in the field. Commissioner LaGree asked if Mr. Kowalski feels the timeframe is possible. Mr. Kowalski replied that he does believe it is possible and further explained why. Chairman Schad questioned if there is any way to find something that captures the scopes of this work for an IUP submission this June. Executive Engineer Kowalski noted that in Arcadis' proposal the IUP application was filled out and included them so that is almost complete and once the contract is in place, the engineering report can be developed and then submitted to further complete that submission for the IUP. All the paperwork will be submitted prior to that June date this year. Mr. Schad requested a list of projects that the Authority is targeting for the IUP filings.
