#### A) SECRETARY

#### 1. RFP – Cybersecurity Risk & Vulnerability Assessment

Secretary McCracken informed the Board that a Request for Proposal for Cybersecurity Risk & Vulnerability Assessment was issued to five firms in addition to the RFP being posted on the Authority's website. Eleven valid responses to the RFP were submitted, and after a thorough review, staff recommends a professional services contract be awarded to GlobalSecurityIQ. Mr. McCracken added that a resolution for the awarding of a contract is on today's agenda.

#### 2. Additional Vacation Time for New Employee

Secretary McCracken informed the Board that on today's agenda is a resolution granting Mr. Walter Klein two week's vacation for one time only. He is the Authority's new Operational Analyst & Solution Programmer which is part of the Authority's restructure of the IT department. Mr. Klein has 40 year's experience in the information technology field – many of these years working for the Authority.

#### 1. RFP – Distribution Main Design Project 2021-2022, Project No. 202100075

Leonard Kowalski reported that a Request for Proposal (RFP) for engineering services for design and construction phase services to replace several distribution mains in the Towns of Hamburg, Cheektowaga, and West Seneca was issued to five (5) consulting engineering firms. In addition, the RFP was posted to the ECWA website. All five engineering firms responded to the request, and three additional firms responded to the posting on the website. Based on the review and evaluation of the proposals, it is the committee's opinion that JM Davidson is the best firm for this project due to a combination of experience and qualifications. Engineering will move forward with negotiations with JM Davidson for the design and construction phase services for this project.

#### 2. RFP - Water Storage Tank Rehabilitation, Project No. 202100021

Executive Engineer Kowalski reported that a Request for Proposal (RFP) for consulting engineering services for the refurbishing of six water storage tanks within the Authority's system was issued to five consulting engineering firms. One other firm obtained the RFP through the posting on our website. Two firms chose to submit proposals for this project. The project consists of engineering services for the design and refurbishment of two tanks owned by ECWA (Colvin and Eden 4), three tanks owned by the Town of Boston (Crestwood, Rice Hill, and Wohlhueter) and one tank owned by the Town of Orchard Park (Cole). Signed cooperative agreements for the construction costs have been received from the Town of Boston and Town of Orchard Park. It is anticipated that three separate construction contracts will be prepared. Based on the review and evaluation of the proposals, it is the committee's opinion that Wendel provided a highly qualified project team and demonstrated direct, relevant experience with similar work. Engineering will move forward with negotiations with Wendel to develop a Professional Services Contract for the referenced project.

3. RFP – Criticality Review, Emergency Action Plan, and
18-Mile Creek Crossing Replacements for Sturgeon
Point Water Treatment Plant Delivered Water Transmission
Mains, PN 202100078 (CCCI)

Leonard Kowalski informed the Board that a Request for Proposal for Criticality Review, Emergency Action Plan, and 18-Mile Creek Crossing Replacements for Sturgeon Point Water Treatment Plant Delivered Water Transmission Mains was issued to four (4) firms. The RFP was not posted on the website due to nature of the project. The Authority received four (4) responses, and it is the committee's opinion that Brown & Caldwell is

the best firm for this critical and complex project due to a combination of experience and qualifications. Engineering will move forward with negotiations with Brown & Caldwell to develop a Professional Services Contract for the referenced project. Commissioner Schad asked about the cost of the project and timetable. Mr. Kowalski replied that the cost will be about \$1.9 million, and he is aiming to have a final report next spring. A brief discussion was held regarding any impact this project may have on any current capital projects.

4. RFP – 42" and 48" Transmission Main Condition Assessment & Transient Analysis, PN 202100079 (CCCI)

Leonard Kowalski informed the Board that a Request for Proposal for a 42" and 48" Transmission Main Condition Assessment & Transient Analysis was issued to three (3) firms. The RFP was not posted on the website due to nature of the project. Three (3) responses were received, and interviews were held with each consulting firm to allow the firms to answer any follow up questions that the engineering department had. Subsequently, the committee determined that Brown & Caldwell is the best firm for this critical and complex project due to a combination of experience and qualifications. Brown and Caldwell provided an experienced project team who demonstrated significant experience with transmission main inspection and transient analyses. Engineering will move forward with negotiations with Brown & Caldwell to develop a Professional Services Contract for the referenced project. Chairman Schad asked if the RFP was solely intended for the southtowns, and Mr. Kowalski informed him it is focused on approximately 32 miles of transmission mains in the Southern Tier. Mr. Kowalski added that this is the tool that can be used on prestressed concrete pipe. Therefore, the results of this project will help us determine if we need to move forward with other locations within our distribution network.
