A. Audit Services RFP

Discussion

Karen Prendergast distributed a proposed RFP for Audit Services. She explained the last time an RFP was sent out for Audit Services was in 2014. Drescher and Malecki was then retained to perform these services for a three-year period and two (2) one-year extensions. That has been exhausted, so an RFP is now needed. Ms. Prendergast is recommending that the Audit Committee recommend to the full Board approve the solicitation of this RFP. Chairman Schad asked if the contract was a fixed price contract or hourly. Ms. Prendergast replied that because it's an RFP the bidder can present it in any way they choose. She asked for a fixed amount for the audit and an indication of how many hours was anticipated. They could do either a fixed amount or an hourly rate for the agreed-upon procedures and for the bonds. Vice Chairman Carney asked what month the audit is completed. Ms. Prendergast replied that the auditors come in before the end of the calendar year sometime in the last quarter to do some preliminary testing for internal controls. The Authority requires that their report be completed and presented to the Board by the end of March so sometime between mid-February and the end of March is when they come in and do their testing.
