SUBJECT: Adoption of Policy No. 98 Notice to Employee

On September 4, 2024, the Governor signed a bill which amends New York State Public Officers Law § 87 to include an additional subdivision, § 87(6). Subdivision 6 requires that public agencies, including public authorities, "develop a policy regarding providing a notification to public employees in the event that the agency is responding to a request for such employee's disciplinary records." The law became effective on September 4, 2024, and does not refer to a compliance deadline. However, it is recommended to comply as soon as possible.

The Legal Department has drafted Policy No. 98 to comply with New York Public Officers Law § 87 and it has been included in the November 21, 2024 Governance and Board Meeting packets for your review and approval to adopt.

PURPOSE

New York Public Officers Law § 87 (6), requires the Authority to establish a policy regarding providing a notification to employees when the Authority is responding to a Freedom of Information Law request for an employee's disciplinary records.

POLICY

When the Authority is in receipt of a Freedom of Information Law request for any Authority employee's disciplinary records, the Secretary of the Authority shall notify the subject Authority employee within three (3) business days of the Authority's receipt of such request.
