Subject:

Service Connection Workorders

Service connections less than or equal to two inches (small services), are originated through a standard application process. Customers complete the application and pay the connection fee indicated in the tariff.

Larger services are originated through a contract between the Authority and the applicant. Applicants pay the actual cost of the service installation, with a deposit for the estimated cost due at the time of contract execution.

Authority Construction Inspectors visit the site and if the water lines have been installed, they generate a workorder for installation. New services are installed by Authority contractors—currently, Russo Development Inc. and 716 Site Contracting, Inc. for small services and Kandey, Inc. for larger services.

It has been the practice of the Authority, to request the Board approve and/or ratify the issuance of these workorders after they have been reviewed by the Distribution Engineer and Comptroller.
