Service Deposit Refunds

The Authorization Form for Large Service Deposit Refunds is attached.

Service connections in excess of two inches (2") are billed to our customers at actual cost plus overhead. At the time of application, an estimate of the cost to install the service is prepared by an Engineering Draftsworker.

The applicant must sign an agreement to pay the actual cost of installation and provide a deposit in the total amount of the estimate before the work can be started. At the time of completion, all costs are tabulated and the applicant is either invoiced for the cost in excess of the deposit amount or refunded the balance remaining if the estimate was higher than the actual cost.

The list attached to the Authorization Form represents those services which have been completed and refunds are due the applicants.
