Subject: Furnish and Deliver Butterfly Valves, Flange Adapters, and Ductile Iron Pipe For Erie County Water Authority Broadway Pump Station ECWA Project No. 201800182

This contract is to procure capital improvement items to be used at the Broadway Pump Station located at 6224 Broadway, Lancaster NY. This facility is an asset of ECWA. All materials will be delivered to 3030 Union Road by common carrier. The old parts will be removed and the new parts will be installed by ECWA employees.

On Tuesday, October 23, 2018, the Authority received four bids for the above referenced contract. The bids have been reviewed, a mathematical check has been performed, and the low bidder is Lock City Supply, Inc. (\$12,822.00). Lock City Supply, Inc. is an established vendor for the Authority. Therefore, I recommend award of the contract to Lock City Supply Inc. in the amount of \$12,822.00. Lock City Supply, Inc. provided required insurance which was approved by the Authority's Risk Manager.

Since this is Invitation to Bid ("Short Form"), the contract is already executed by the Contractor. The MWBE requirements and wage rates requirements are not applicable. Since the insurance requirements are met, the contract can be awarded and executed by ECWA Chairman pending Legal review.
