Subject: Recommendation for the Appointment of a Part-time Associate Attorney

Due to the resignation of Jennifer Runfola, the Erie County Water Authority (the "Authority") posted the part-time position of Associate Attorney. On Monday, December 17, 2018, Jacqueline Mattina, Shari Zajdel and I conducted interviews with the two applicants, John J. Gilmour and Tina M. Hawthorne, who applied for this part-time position. After interviews were conducted, the Authority received a resume from a third applicant, who will be interviewed, if another part-time position becomes available within the next few months.

Ms. Mattina, Ms. Zajdel and I agree both Mr. Gilmour and Ms. Hawthorne were outstanding candidates and if more part-time positions were available at this time, both applicants would be wonderful additions to the Legal Department. I reviewed the references for both candidates, confirming they are dedicated, hardworking individuals who have strong legal reasoning skills and who are capable conducting their own legal research. Both candidates are personable, well-spoken and professional in their appearance. Any legal office would benefit from hiring either of these individual, in my view.

After consulting with both Ms. Mattina and Ms. Zajdel, I have decided to recommend Mr. Gilmour. Mr. Gilmour fits the current needs of the Legal Department. The Legal Department would benefit from an attorney who has dealt with union grievances, is familiar with the Civil Service Law, and had some experience with personnel matters. One of the items on the Legal Department's agenda is the review of the Authority's HR Policies. Additionally, Authority's HR Director Daniel NeMoyer reviews personnel matters with the Legal Department, including matters involving progressive discipline of those within the classified civil service. Mr. Gilmour has a labor law background, which would benefit the Legal Department. I have attached a copy of Mr. Gilmour's resume to this recommendation.


