Please include records from January 2024 to the present.

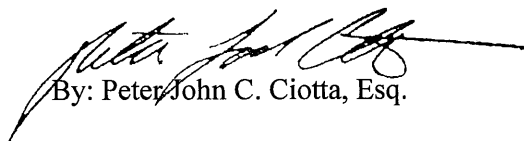
