PLEASE TAKE NOTICE, that KELLIE P. BOLDEN, has and hereby makes claim against COUNTY OF ERIE and ERIE COUNTY WATER AUTHORITY, and in support of said claim states the following:

1. The Post Office address of the claimant is 1033 Ellicott Street, Apartment 2, Buffalo, NY 14209.
2. The attorneys for the claimant are LIPSITZ GREEN SCIME CAMBRIA LLP, and their Post Office address is 42 Delaware Avenue, Suite 120, Buffalo, New York 14202-3924.
3. The claim of KELLIE P. BOLDEN is for personal injuries, including without limitation, loss of income and medical expenses.
4. The claim arose at the intersection of Union Road and Fath Drive, located in the Town of Cheektowaga, County of Erie and State of New York.


5. The claim arose in substance as follows: On the 9th day of August, 2022, at approximately 1:23 p.m., the claimant, KELLIE P. BOLDEN, was operating her vehicle on Union Road at a point near its intersection with Fath Drive, both public highways located within the Town of Cheektowaga, County of Erie and the State of New York, when a vehicle operated by COUNTY OF ERIE and ERIE COUNTY WATER AUTHORITY came into contact with the vehicle operated by the claimant, resulting in serious injuries to the claimant.

6. Upon information and belief, the incident herein described and the resultant injuries and damages sustained were caused as a result of the negligence, carelessness, recklessness and/or unlawful conduct on the part of the agents, servants and/or employees of COUNTY OF ERIE and ERIE COUNTY WATER AUTHORITY.


7. Upon information and belief, as a result of the aforesaid incident, the claimant, KELLIE P. BOLDEN, sustained severe bodily injuries and was painfully and seriously injured; was rendered sick, sore, lame and disabled; sustained pain and suffering and shock to her nerves and nervous system; and more particularly, KELLIE P. BOLDEN, sustained injuries to her head, right hand, left shoulder, right knee, right hip and back. Upon information and belief, these injuries will result in permanent defects.

WHEREFORE, claimant requests that COUNTY OF ERIE and ERIE COUNTY WATER AUTHORITY honor and pay the claim on behalf of KELLIE P. BOLDEN.


