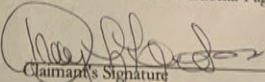
Claimant's Statement (please be specific):

The water was running down into the ^{epine} fairwell to my basement. I ran to the basement to see if water was coming in. At that moment I began to see the water running under the door. There was nothing I could do to stop the water and I went back upstairs to look out the front window and saw a river of water traveling south (mostly) down late shore rd. and onto the front lawn of my neighbor's house (to my right), into my driveway through my back yard, and rushing across my front lawn and continuing down the rd. The source of the water was across the street from me and one house over (directly across from my house to my right). I could see water gushing into the air at least 4' high. The water continued to gush for at least an hour. There was rock and pieces of debris on the road and in our driveways (mine & neighbor's).

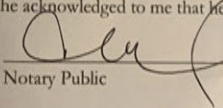
