I represent a client, Kevin Letersky, who was injured in an incident on April 4, 2019. At this time I would request copies of the following documents:


1. All dispatch recordings for 4/4/19 regarding a water main break at the corner of Hanford and Blanding in the Town of Hanover.

4. The names of the Water Authority workers or contractors who responded to the water main break at the corner of Hanford and Blanding in the Town of Hanover on 4/4/19.

5. Any and all communications and/or correspondence in any form between the Erie County Water Authority and Dig Safe and/or National Fuel and/or from any party about the accident involving Kevin Letersky on 4/4/19.
6. Any incident report or accident investigation report prepared by the Erie County Water Authority involving the accident of Kevin Letersky at the on 4/4/19.
7. Any and all communication between the Erie County Water Authority and National Fuel and any and all other parties regarding Kevin Letersky's injury / accident.
8. The name of the contractor that repaired the water main break at the corner of Hanford and Blanding in the Town of Hanover on 4/4/19.
