Claimant's Statement (please be specific):

the water main break completely destroyed their concrete driveway creating a gushing river of concrete, debris (it was garbage clay), gravel, and flooded by a river of muddy substance. This debris, gravel, rock, concrete material, garbage, and more destroyed not only our front yard, under our bushes, but ran through & past our garage, our home, & our shed, our sons playset, and all over our driveway. Although not in the best shape in the first place, the exterior of our garage, and our shed were impacted by ECWA'S river. Being very cold that day, and this extremely dirty river attacking our driveway, the driveway has deteriorated and is worse than ever. (Impact of floodwater, impact of changing temp., expanding & contracting, etc.) My fiancée has attempted at powerwash the disgusting soot & all previously mentioned, but the driveway remains dirty and in shambles. We've done our best to pick up the garbage & all that has flowed through. Inside the shed & garage were able to be salvaged but lower exterior took a hit & doesn't look as it did before. Waterproofed in November '20 (we never had flooding, but neighbors said previous owner had complaints so we did it just in case). Fixer running especially since the incident, our dehumidifier in semi-finished basement fills daily since incident. We always ran as precaution previously, and it took 1-2 weeks to get anywhere close to full. The waterproof is now having water come through, and moisture breaking through.
