We came home from a wedding about 12:30 am on 8/8/21 and our driveway and yard had no water. We went to bed and were awoken at 4:30 am to our Alarm going off. We realized it was the sump pump and ran down into the basement. My husband checked the pump and saw it was working, but not keeping up with the water pouring into the hole. He went outside and saw the water everywhere and the geyser of water coming out from under our driveway. He yelled to call ECWA and I did right away, so about 4:40 am. I was told there was only one guy on duty and he would get there and shut it off. At that time our basement was not flooded. Within 20-30 minutes it was starting to flood around the edges. I called the emergency number again saying they had to shut off the water main ASAP. My husband was outside looking for the truck and guy to come and when he came back down to the basement, it was completely flooded.

It took the emergency guy almost 3 hours to shut the water off as our basement continued to flood more and more. During this time, we were able to call a friend that had a commercial 2 inch electric pump and with both pumps running, we were just barely able to keep the water from ruining the insulation around the walls. However everything that was on our floor was ruined due to water damage. We lost thousands of dollars of winter clothing, shoes, rugs, household items, irreplaceable pictures in frames that took on water, small appliances, decorations, games, puzzles, books, etc. that we will have to make a list of approximate value for our damages - Also, we had to cancel our flights scheduled for that day and reschedule a trip we had planned for months, which cost us more money for rebooking and also caused us to lose 2 days of our vacation. We will add up all of our losses and be sending a repair and loss estimate at a later date.

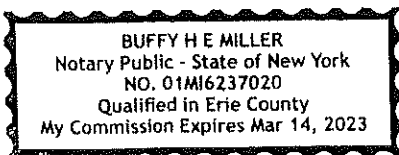

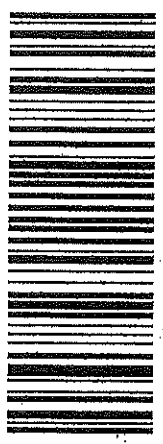
