
Claimant's Statement (please print legibly and be specific):

On Thursday February 19th 2026 around 4:30pm, I was making a right hand turn on to Drechsler Court from George Street in the village of Hamburg, NY when I heard a loud sound and felt an impact to my vehicle. I immediately stopped my van and got out to investigate. There was noticeable damage to the front drivers side of my bumper and a bent pipe sticking out of a hole in the ground with the lid to the hole beside it, under my car. (which was later determined and explained to be a key that was left unattended in the middle of the road in a water valve). There was no visible signage, cones or flaggers present to warn drivers of any hazards in the roadway. I was approached by an Erie County Water Authority employee (Dragon), who was working in the yard to the right. He asked if I was alright and apologized. He then proceeded to call the incident in to his supervisor and take pictures of the scene and the damage. I called the Village of Hamburg police who arrived on scene and filed an incident report. My van was damaged due to the Erie County Water Authorities negligence for ^{not having} proper warnings to be present, that work was being done and I'm asking for them to fix it and provide me with a vehicle while mine is being fixed.


