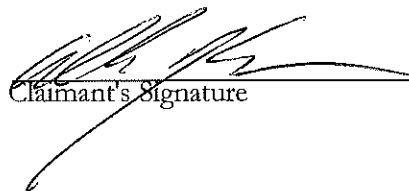
Claimant's Statement (please print legibly and be specific):

02/06/2022 - The water authority came to our property at 85 Follett Ave, Cheektowagon, NY 14225 to fix a water main issue. (10pm that night)
02/07/2022 - Water/sewage begins to bubble up from basement drain. We contact water authority and are advised to call sewer authority and plumber first. Sewer Authority comes and flushes sewer lines and plumber comes out to inspect issues (please see invoice 107659823 from 2/7/22). Issue is not resolved (3pm-10pm). We call Water Authority emergency line. We are told a crew will come out to inspect.
02/08/2022 - 2:00am - Crew comes to house and I explain issue. Advise I can go back inside while they inspect. I fall asleep and wake up a few hours later and water has stopped bubbling from drain and the crew is gone. In the morning, approximately 8am, Catherine calls contact at Water Authority and was advised they called in a plumber who snaked line and issue resolved.
4/25/2022 - Crew shows up to prep front sidewalk for repair by digging up concrete and laying gravel. Later that evening the issue from 2/7 starts again. We call the water authority, sewer authority and plumber. Follow same protocol as before. Plumber comes out (please see invoice 113204933 from 4/25) and snakes line. Plumber notices snake is struggling to clear blockage but it does clear blockage to resolve issue. Advises a tech with a camera line to inspect it will come out next day for free.
4/26/2022 - Tech inspects the line and advised there is broken drain tile in line and needs to be replaced. Job scheduled for May.

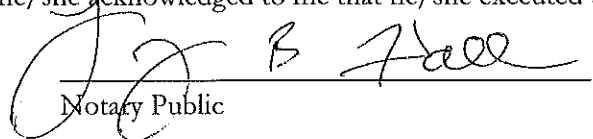

05/13/2022 - Crew comes out from Roy's Plumbing to repair line (please see invoice 113384929 from 05/13).

Crew spoke to Catherine who was home at the time and asked if work was done on the watermain. Catherine advised about the incidents from February to the crew. The crew ended up contacting the water authority and someone came out to inspect the site to see damage. Water authority representative spoke to Catherine and the crew and said that we can bill the water authority ~~expense~~ as also noted on invoice 113384929). But since job was already paid for through financing we were given phone number for Molly Jo Musarra to contact to file claim. Was advised by Roy's crew that since the damage was more than they thought they would have to finish the job at a later date.

5/23/22 - Roy's crew comes back out to house and completes job.
