I had to have utilities shut off and NYSEG wouldn't turn my power on until I got it inspected. Upon inspection it was found that my electrical box had corroded wires and needed it fix. After it was inspected and power turned back on, Service came in to clean mud and water, sampling for mold. I then had rvs replace the hot water tank (it was underwater). The next replacement will be my furnace. (it too was under water). Finally, I will need a new washer and dryer because they were under water also.
