**Claimant's Statement (please be specific):**

On November 9<sup>th</sup>, E.C. Water serviceman came out to find shut off because of noise at service entry of 5058 Parker Rd. He found it, shut it off and noise went away, He also stated leak was on customer side and customers responsibility with no mention of any further investigation.

On December 11<sup>th</sup>, VIO Plumbing dug half way up to house to find water service and found it. They tried pulling old service through wall to keep in same place but did not work. They relocated service and tried in to house. After reconnection, noise still at new entry point and in their hole and could slightly be heard at shut off valve.

Called E.C. Water and dispatcher denied responsibility and gave phone number of Supervisor Tom Gadi to call and talk to.

On December 14<sup>th</sup> contacted Tom Gadi and discussed issue. He informed me he would have a sound test crew investigate issue. December 15<sup>th</sup> the sound crew arrived and investigated. The sound crew identified an issue at service tap to main and stated issue was quite apparent to my wife.

On December 15<sup>th</sup> E.C. Water crew repaired leak at service tap to main, Claiming reimbursement for water service renewal, lawn regrading, repair mailbox installation, materials and labor to close off new water meter to be done by my self and depreciation of value.

All statements herein are made under penalty of perjury.
