My complaint stems from the fact that I am being over charged for water that has never been used for a household of 3 whom do not take showers or baths daily. We may wash clothes 2 times out of a week. In addition there are no leaking toilets, faucets, or pipes. The water bill for periods 3/4/21 to 6/3/21 had significantly increased to \$671.07 and currently jumped to an astonishing, mind-blowing, \$738.18. This billing cycle contains 182,000 gallons of usage. In June I spoke with an ECWA Rep., that implied I must have something leaking or was not aware of my water usage???

The last bill cycle 12/3/20 - 3/4/21 totaled the amount of \$200.98 in which \$206.08 was received by the company. Last billing cycle payments go as follows: March 29th, 2021 payment of \$150 was provided and May 10, 2021, \$56.08 was provided. The water usage for that period was a 33,000 gal. My past history of water usage explains itself. There seems to be a miscalculation of the current bill and usage of water.

I have just commenced with a job after returning from months of assisting my ill uncle, paying for extensive medical bills, and am struggling to make ends meet. This bill came out of "left field" and the water usage charged is that of a "car wash" facility. I am seeking to have this matter analyzed and I am willing to provide all documentation receipts relative to this issue. Most importantly, I am seeking an adjustment on the current bill.
