DESCRIPTION OF WORK

We began by excavating in the front right side of home. We excavated a 60' x 1' x 4' trench out to the existing curb box. We were able to tunnel under the walkway pad without removing it. Once down to the curb box we were able to tie onto a stub of copper coming off the curb box on the house side. We then ran 3/4" K copper from the curb box to the meter inside with a new wall penetration. We then used hydraulic cement to plug the old water line hole to prevent leaks from the foundation we also hydro cemented the new penetration as well. We then tied onto the existing copper in the home and put in a flare angle meter valve for a whole house shut off. We then tested the new system for leaks then backfilled the trench 12" above grade to prevent harsh settling.

Upon cancellation and/or breach of this contract beyond the terms outlined in bullet 1, I understand that the deposit collected will be withdrawn from escrow to cover Roy's reasonable costs incurred for this job at the point of contract breach, and any remaining deposit funds will be refunded to me through my original payment method thereafter in accordance with NYS law.
