

Dear Mr. Alessi:

1. I wish to acknowledge your courteous, prompt and efficient response associate with this claim. The Erie County Water Authority – given the extent of the damage to my basement and its contents – was exceptional. In a separate email, I acknowledged the rapid and expert response of Crew Chief Mike Fahey. He wasn't sure what caused this disaster; nonetheless, he vowed to keep me informed about what was being done to the resolve the situation.
2. Attached please find my claim form.
3. Included please find:
 - a) A paid invoice of **\$4429.96** -- from Ryan DeWaters HVAC --covering the materials and labor for removing the water, cleaning the walls, floor and carpeted stairs; drying out the basement; the cost and labor for installing a new hot water heater; the parts and labor for repairing the furnace and boiler; the cost of removing the damaged washer and dryer and picking-up the new ones.
 - b) A paid invoice for **\$1080.98** from Orville's Appliances for a new washer and dryer.
 - c) The estimated cost of **\$74.98** for replacing my Lasko Column Fan.
 - d) The total damages amounted to **\$5585.92**.
4. Unfortunately, I can't estimate the replacement cost of the many framed paintings, plaques, diplomas, photographs and prints stored in cardboard cartons that were submerged in sewer water.
5. As you requested, I will email you the photos.
