on the evening of 12-8-2020 OUR SON, Andrew MAST went downstairs to read the water meter that is located in a closet in our office/spare room. When he read the meter he discovered it was dripping/leaking and the carpet was water saturated, dry wall, mouldings, framing, baseboards, paint, wood studs all were water damaged and black mold present. We placed a pan under the meter to catch the water once the leak was discovered, on the morning of 12-9-2020 I called ECWA and a tech. came out to check the meter, I took pictures and video of the leaking meter, the tech fixed the leak. Attached you will find the Home Owners Claim I sent into Allstate, along with the estimate they provided, also a letter from them stating they will not cover the damage of the wood & mold due to seepage over a period of weeks, months etc. They will only cover sudden damage, so the estimate and money they sent us \$1451.21 does not cover all the damage expenses to our room. They estimate \$1951.21 less our \$500 deductible they paid us \$1451.21.
