Water lines have been being installed for the last couple of months on Pleasant Ave. by Erie County Water Authority and a contractor. On the morning of October 6, 2022 we found that the water was shut off. By the way we were supposed to be notified when this was to take place but never were. At approximately 10:00 AM my wife turned the faucet on in the kitchen to check and see if the water had been turned back on. When this happened air came out of the faucet followed by high pressure water which caused the aerator to shoot out of the faucet and water to shoot out of the top of the faucet. I contacted Theodore Roland the inspector on the job and he told me to call Molly Mussarra at the Water Authority to report what happened. She told me to have it fixed and fill out this paperwork for reimbursement.
