On November 11 2022, there was a water main break on Cimarron Drive on the east side of the street in front of our resident's home of 35 and 59 Cimarron Drive. The watermain break ran for several hours causing flooding of our property and the road. The flood waters carried soil and debris into two of our driveways flooding six garages and sidewalks. Water levels also were high enough to go into the finished basement at 59 Cimarron.


As the water receded it left behind several inches of fine-grained soil and sand throughout the property. Initial clean up that was done by our maintenance company required shoveling off the driveways and sidewalks to prevent slip hazards for residents and visitors. I have enclosed a quote for the next phase of cleanup. The next phase of clean up requires power washing the driveway and sidewalks. The total is based on the amount that has already been paid. The rest of the restoration will not be able to be completed until spring. I will not be able to get quotes until then. So, this is an ongoing project.

There is more to be done I am requesting reimbursement for our current costs and all future costs in spring.
