BEGINNING OCT. 25<sup>TH</sup> 2020 - OCT. 27<sup>TH</sup> 2020 MY NEIGHBORHOOD EXPERIENCED 3 WATER MAIN BREAKS ON NEW TAYLOR ROAD IN ORCHARD PARK. THE FIRST 2 BREAKS CAUSED EXCESSIVE WATER TO RUN THROUGH MY FRONT YARD. THAT WATER CAUSED A BLOCK IN A STORM LINE WHICH MY SUMP PUMP EMPTIES INTO. THE THIRD BREAK WHICH OCCURED FURTHER UP NEW TAYLOR BROUGHT WATER RUNNING THROUGH MY BACK YARD AND BACKED UP MY SUMP PUMP AND CAUSED A FOOT OF WATER TO ACCUMULATE IN MY BASEMENT. HAD THE BLOCKAGE NOT OCCURRED FROM PREVIOUS BREAKS MY SYSTEM WOULD HAVE BEEN ABLE TO HANDLE THE WATER. THERE WAS MINIMAL DAMAGE TO THE BASEMENT AND I WILL HANDLE CLEAN-UP. I AM ASKING THAT THE BILL FROM M. PURTIL PLUMBING OF \$353.44 BE COVERED WHICH WAS A FIX TO ENSURE MY SYSTEM WILL HAVE SOMEWHERE TO DRAIN. PRIOR TO THOSE 3 WATER MAIN BREAKS MY SUMP PUMP AND DRAINAGE WORKED PERFECTLY AND HAD THE FIRST 2 BREAKS NOT OCCURRED WE WOULDN'T HAVE HAD A PROBLEM.


