Property damage was sustained at our house (James/Sara Erb, 4982 Burlbrook Dr) as a result of ECWA workers trying to repair a water main break at the corner of Burlbrook Dr and Abbot road.

Per the ECWA workers on site (Dragon, Steve), as they were trying to make a repair on a pipe, the pipe burst, which sent an extremely large amount of water down the street and into our yard.

The amount of water was so large and the flow was so high that it moved across the driveway and into the garage, covering one entire garage bay in water. That water also flowed into the part of the house closest to the garage. The water covered the entire floor of one bedroom, part of the hallway, and most of another bedroom. The flooring areas / types / approx. sizes that were affected by the water are as follows:

Garage: carpet, 300 sqft

hallway: carpet, 200 sqft

bedroom 1: vinyl, 100 sqft

bedroom 2: vinyl, 100 sqft


In addition to the damaged flooring, sheets of spare drywall, wood siding, and cardboard storage boxes that were located in the affected area of the garage were also soaked from the water.
