Due to a water main break on 2/25/2021 at 10:45am, our home located at 7075 Lake Shore Rd Derby, NY sustained exterior damage to our driveway and the water damaged personal property located in our attached garage and outbuilding located behind the house. There was also standing water in our basement - a claim was filed with our homeowners insurance company for the interior property damage. The claim information is attached as well as the payment for remediation services. Due to the water running over the driveway, it was damaged in multiple areas where the asphalt was washed out. Also, when the temporary patch was put in, the dump truck and excavator cracked the driveway further. Attached is a detailed list of items located in our garage and barn that are damaged due to the water. The driveway needs to be repaired/replaced and the total loss to personal property totals \$33,200.

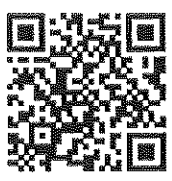
