Please be advised that our office represents Cecelia Sztaba, owner of A King's Ransom Thrift Shop located at 3748 South Park Ave., Blasdell, NY 14219. We are investigating a significant water/mud/sewage intrusion event that occurred on August 18-19, 2025, caused by work being performed by or on behalf of the Erie County Water Authority at Frontier Blasdell Elementary School, 3780 South Park Ave., Blasdell, NY 14219.

Pursuant to the New York Freedom of Information Law, kindly provide all records, documents, reports, photographs, videos, work orders, and communications relating to any ECWA work, maintenance, construction, repair, excavation, or emergency response occurring at or near Frontier Blasdell Elementary, or otherwise affecting South Park Avenue, between August 1, 2025 and September 15, 2025.

Specifically, this request includes but is not limited to:

- **Work Records & Logs**
All work orders, job tickets, daily logs, maintenance logs, and service orders for any ECWA work performed at or near **3780 South Park Ave., Blasdell, NY**, between **August 1 and August 31, 2025**.
- **Description of Work Performed**
Any documents describing the nature, scope, purpose, and location of the ECWA work performed at or near that address during the above period.
- **Incident / Complaint Records**
Any incident reports, service calls, complaints, or other records reflecting flooding, water intrusion, runoff, or operational issues reported on or near **South Park Ave.** on
