Dear Mr. Shad,

Reference is made to attached letter and bill from ECWA.

I am very upset over what I am reading. When I received the letter dated July 7 informing me of my excessively high reading, I got very concerned. I immediately called my plumber (AND ECWA) and he came to my home Tuesday, July 14, and did a thorough inspection and found NO leaks.

8,000 THOUSAND GALLONS OF FOR TULY

He read the meter and at that time it was 33227445 and the flow rate was ZERO.

I have NO outside water for hoses. I had it turned off last Winter. I have NO sprinklers, no pools and I don't even water my flowers as I don't have my hoses hooked up.

The water to upstairs bathroom and toilet is shut off since I don't use the upstairs.

I had two major surgeries this year, the latter being July 7th, and every time I leave my home for an extended time, I have the water completely shut off for the entire house. Also, I was not even allowed to shower during July due to my eye surgery.

I have done little washing in m y washing machine as it has not worked property for months. I do use my dishwasher.

I am a 70 year old widow, blind in one eye and on a limited budget. I am the only one living in this house. My husband,

Thomas Yaeger, passed away March of 2013 but I see his name is still on the invoice.

I took a reading this morning and meter read: 33263392.

People have asked me if people are tapping into my water and that would be impossible since the outside access is turned off and I know my neighbors very well.

I did notice a neighbor directly across the street from me, who has an inground pool, always seems to have a long hose coming from his pool, and he inserts it in his lawn in front of his home on the N. Creek side.

Could I need a new meter? Is the water pressure set at a certain rate?

My plumber came BACK here, yesterday, Thursday, July 16, to fix a pipe in my sump pump. A pipe broke while I was home so I was lucky he could come by and fix it. I have a BATTERY back up sump pump.

Again, he assured me my house has NO leaks.

Baasement is dry.

No leaking faucets.

His name is Luke Hallick and owns Modern Plumbing. I have been using him for 7 years and he is very qualified.

This plumbing cost and now the ECWA bill is costing me a lot of money.

If you feel the \$291.07 bill is non-negotiable, please advise and I will pay it immediately.


