After turning the water on and off there were no signs of a water line break. We did further investigating by doing a dye test, chlorine test, etc. we found a shut off valve for what appeared to be an irrigation system. Due to it not being properly winterized, shutting the valve off stopped the flow of water into the sump crock as well as water traveling through the meter. Discussions were made on our behalf with Erie county water authority regarding their diagnosis and the excavation.
