On Wednesday, February 2, 2022, the Authority received bids for the above referenced contracts. Prior to the bid opening, the Bid Notice was publicly advertised for 23 calendar days and the Authority received responses from four (4) bidders.

After reviewing the bids, the Engineering Department consulted with the Legal Department regarding these bid submissions and the decision was made to reject the bids.

Pursuant to Public Authorities Law § 1069, ECWA has the authority to reject all bids if it is in the Authority's best interests. Article 22 of the Instructions to Bidders also states the Authority has the right to reject any or all bids, as well as to re-bid the contract if the Authority deems such action to be in the public interest. The power to reject all bids, as set forth in Public Authorities Law § 1069, is like the power given municipal corporations pursuant to General Municipal Law § 103.

Both the Legal and Engineering Departments recommend the Board rejects all the bids submitted on February 2, 2022 and authorize the advertisement for new bids.

Budget Information: The tanks under Contract W-034-A are owned by the Town of Boston and leased-managed by the Authority. The Town of Boston has bonded for the contractor cost and will compensate the Authority directly in accordance with our Cooperative Agreement. Payments to the Contractor will be from an ECWA OWIP (Opening Work in Progress) account.
