Subject: 2023 Capital Budget Transfer Sheridan Drive Water System Improvements PN 202200206

The Engineering Department is requesting the transfer of funds to fund the construction and engineering fees (construction administration and resident inspection) associated with the above referenced distribution system improvement project.

This budget transfer is required to fund work to be completed in 2023. When the 2023 budget was being developed, the complete scope of the NYSDOT project was not completely identified. Coordination with NYSDOT continued after the budget process and ECWA tailored our project to match the limits provided by NYSDOT. Based on the scope of work for the NYSDOT project, a substantial amount of problematic main can be replaced, improvements can be made to the system hydraulics as well as provide for improved operations and maintenance.

A total of \$6,000,000.00 is being requested to be transferred to this project split equally between Contract W-030, Transmission Main Replacement – Town of Amherst and Contract MP-090 – Sturgeon Point Filter Gallery Piping Replacement. Funds are available Contract W-030 due to ongoing project delays caused by property access/acquisition issues with National Grid, The State University at Buffalo, and an adjacent private lot. Funds are available in Contract MP-090 due to delays associated with rebidding the project. Attached find a fully executed Budget Transfer Form.
