AMENDMENT NO. 2 HEATING, VENTILATING, AND AIR CONDITIONING (HVAC) SERVICE AND PREVENTIVE MAINTENANCE WORK

AMENDMENT NO. 2, effective July 16, 2020 (the "Amendment"), to the Heating, Ventilating, and Air Conditioning Service and Preventive Maintenance Work with the Erie County Water Authority's Facilities (Contract No. 17-10-07), entered on the 13th day of July 2017, by and between

hereinafter referred to as the "Authority," and

MOLLENBERG-BETZ, INC.

300 Scott Street Buffalo, New York 14204

hereinafter referred to as the "Contractor."

WHEREAS, on July 13, 2017, the Authority and the Contractor executed a two-year, HVAC service and preventive maintenance agreement (Contract No. 17-10-07)(hereinafter "the Contract"); and

WHEREAS, on March 7, 2019, the Authority and Contractor agreed to a one-year extension of the Contract; and

WHEREAS, on June 23, 2020, the Authority conducted a bid opening to review proposals for a new two-year, HVAC service and preventive maintenance agreement; and

WHEREAS, the bid proposals opened on June 23, 2020 are under review by the Engineering and Legal Departments; and

WHEREAS, the Authority may need emergency HVAC services pending the award of the new HVAC contract; and

WHEREAS, the Contractor has agreed to provide such emergency services, as a stop-gap measure pending the approval of a new HVAC contract, upon the terms and conditions set forth in this Amendment;

NOW, THEREFORE, in consideration of mutual promises herein set forth, the parties agree to the following:

(1) Section 00500, paragraph 11.00, subparagraph A of the Contract shall be amended to add the following sentence at the end of the subparagraph: "Upon the mutual consent of the parties, the CONTRACTOR may continue to provide emergency HVAC services to the Authority pending the approval of bids and the awarding of a new HVAC service and preventive maintenance agreement."

(2) Labor will be billed at an hourly rate that includes the cost for providing labor, service vehicles, and tools to be used on a scheduled or emergency service call for repairs and installations, at the service rate set forth in Item 1, of paragraph 5.01 of section 00410 of the Contract.

(3) The Authority agrees to reimburse the Contractor for all material and supplies, subject to the pre-approval of the Authority's Chief Operating Officer and Chief Financial Officer prior to repair or installation, for any materials and supplies exceeding \$ 10,000.00.

(4) The parties agree other terms and conditions of the Contract shall remain in effect provided such terms and conditions relate to emergency services.

(5) This Amendment may be executed in counterparts, each of which is deemed an original, but all of which together are deemed to be one and the same agreement; and

(6) The parties agree to accept electronic signature pages, signed in conformity with the Governor's Executive Order No. 202.8, allowing any notarial action to be performed utilizing audio-video technology.

(7) The parties agree the Contract, subject to this Amendment, will terminate upon the award of a contract for Project No. 202000098.
