Subject: 2022 Capital Budget Transfer CH-012 – Water System Improvements, Town of Cheektowaga

The Engineering Department is requesting the transfer of funds and reestablishment of a capital budget item for consulting engineer services associated with additional Resident Engineering fees associated with the distribution improvement project:

• CH-012 – Water System Improvements, Town of Cheektowaga

This budget transfer is associated with additional Resident Inspection fees necessary to reimburse the consultant for work required to provide full time resident inspection services for the duration of the project. The hours included in the original professional services agreement were an estimate and were not adequate to complete the original scope of work. Further, due to unforeseen site conditions the project duration was longer than anticipated. And finally, the Erie County Highway Department requested that the final paving not be completed until the following spring to allow for trench settlement prior to paving.

A total of \$30,000.00 is being requested to be transferred from Contract LA-005 to fund the work. Funds are available due to a delay in bidding the project resulting in a portion of the work originally funded for completion in 2022 to be shifted to the 2023 construction season. Attached find a fully executed Budget Transfer Form.
