Subject: Furnish and Deliver Liquid Chlorine in One-Ton Containers to the Erie County Water Authority for Use in the Treatment of Water for One Year.

The above-referenced contract will expire on July 31, 2026. The Authority and the Supplier, JCI Jones Chemical, Inc. (JCI), agree that a one-year extension of the current contract at the same terms and conditions would be mutually beneficial for both parties. The Contractor expressed interest in extending the current contract in the attached letter dated April 22, 2026.

This unit price contract was initially bid for one year (from September 1, 2024 to August 31, 2025) with a possibility of extension for two (2) additional one-year terms. Amendment No. 1 extended the contract by 11 months, from September 1, 2025 to July 31, 2026, based on the same terms and conditions, including pricing. Amendment No. 2 will extend the contract by one more year based on the same terms and conditions, including pricing. JCI has proven to be a highly capable and reliable vendor. The liquid chlorine they supply is a critical component of the disinfection process and is required by the Health Department.

Based on this information, Engineering Department is recommending a one-year extension for Board's consideration and, if approved, for the Chairman to execute.



**AMENDMENT NO. 2 TO THE CONTRACT TO
FURNISH & DELIVER LIQUID CHLORINE**

AMENDMENT, effective June 18, 2026 (“Amendment No. 2”), to the Contract to Furnish & Deliver Liquid Chlorine, effective on August 15, 2024, by and between

ERIE COUNTY WATER AUTHORITY

hereinafter referred to as the “Authority,” and

JCI JONES CHEMICALS, INC.

100 Sunny Sol Blvd.
Caledonia, New York 14423

hereinafter referred to as “Supplier.”

WHEREAS, on August 15, 2024, the Authority awarded the Supplier a contract to furnish and deliver liquid chlorine to the Authority’s treatment plants (the “Contract”) for a one-year term from September 1, 2024 to August 31, 2025; and

WHEREAS, on July 23, 2025, the Authority approved Amendment No. 1 extending the term of the Agreement through July 31, 2026; and

WHEREAS, in accordance with paragraph 1.04 of the Contract, the parties may agree to extend the Contract on the same terms and conditions, or upon such terms and conditions acceptable to the Authority, for two (2) additional one (1) year terms; and

WHEREAS, in accordance with Article 5, Paragraph 5.02 of the Contract, any modification or variation from the terms of the Contract must be in writing, authorized by a resolution of the Board of Commissioners of the Authority (the “Board”) and signed by all parties; and

WHEREAS, the Supplier has agreed to extend this Contract for an additional one-year period from August 1, 2026 to July 31, 2027, based on the same terms and conditions, including pricing of \$1,820.00 per liquid ton, as set forth in Article 4 of the Contract;

NOW, THEREFORE, in consideration of mutual promises herein set forth, the parties agree to the following:

- (1) The term and conditions of the Contract shall continue in effect until July 31, 2027;
- (2) The parties agree all other terms and conditions of the Agreement shall remain unchanged and in effect; and

(3) This Amendment may be executed in counterparts, each of which is deemed an original, but all of which together are deemed to be one and the same agreement.

IN WITNESS WHERETO, the parties hereto have caused this Amendment No. 2 to be signed by their respective duly constituted officers, attested and sealed pursuant to proper authority.
