Subject: 2022 Budget Capital Budget Transfer William Pump Station Drainage Improvements Creation of New Capital Budget Item

The Engineering Department is requesting the creation of a new Capital Budget Item and the transfer of funds from Capital Budget Item No. 1020-100-101578, Windom Pump Station Automated Gate to the new budget item within Unit 1015.

An USEPA inspection in September 2021 identified drainage and infiltration issues at the William Pump Station, requiring the Authority to complete study, design, and construction services for improvements at the Station to address the issues. These services will be completed by an engineering consultant.

EPA's correspondence requiring the engineering work was received after completion of the 2022 budget, therefore a new budget item and transfer of funds is required.

A Request for Proposals has been prepared and will be distributed to multiple consultants upon creation of the new budget item. It is anticipated that the consultant engineering services will continue through 2023.

Funds are available for transfer from the Windom Pump Station Automated Gate Project as the low bid for the new gate was received substantially below the amount budgeted for 2022.

Accordingly, to complete the consultant engineering services, we are requesting a total of \$70,00.00 to be transferred to the new budget item.
