Subject: 2021 Capital Budget Transfer to PN 202000165 Contract for Furnishing and Installing Pump Station Roof and Siding Replacements

The Engineering Department is requesting the transfer of funds from W-027 Transmission Main Replacement (Unit 2595, Dept. 250, Capital No. 101267) to PN 202000165 Pump Station Roof and Siding Replacements (Unit 1020, Dept. 100, Capital No. 101582).

This contract (PN 202000165) was originally bid in 2020 with five pump station roof replacements and one pump station siding replacement. Due to receiving high bid costs, in 2020, caused by delays in roofing work due to the COVID-19 pandemic, all bids were rejected and it was decided to rebid the contract in 2021. After finalization of the 2021 Capital Budget it was decided by the Engineering staff that additional pump station roofs required replacement and that increasing the contract size would potentially drive down the price per roof. Five pump station roofs were added to the contract, resulting in the replacement of ten pump station roofs in total.

The bids received for the 2021 rebid contract were much more competitive than those received in 2020, as shown below:

- 2020 Average Cost per Roof Replacement = \$46,150
- 2021 Average Cost per Roof Replacement = \$35,600

Based on the bids received the Engineering Dept. would like to move forward with awarding the contract for the replacement of all ten pump station roofs. The 2021 capital budget item (Unit 1020) is insufficient to replace all of the roofs.

Funds for this amendment are available from 2021 Capital Budget Item W-027 Transmission Main Replacement (Unit 2595, Dept. 250, Capital No. 101267). A portion of W-027 was paid under the 2020 Capital Budget Item for this contract, which leaves sufficient monies available for this budget transfer.

A total of \$185,000 is being requested to be transferred for this project as follows:

- Transfer from: 2021 Budget Unit 2595, Item No. 101267, W-027 Transmission Main Replacement
- Transfer to: 2021 Budget Unit 1020, Item No. 101582, Pump Station Roof Replacements
