Subject: Contract Extension (Contract No. 20-16-06) High Voltage, Service, Switchgear Inspection, and Emergency Electrical Work Within the Erie County Water Authority's Facilities ECWA Project No. 202000014

The current High Voltage, Service, Switchgear Inspection and Emergency Electrical Work within the Erie County Water Authority's Facilities Contract was executed on June 1, 2020 and expires on May 31, 2022. This unit price contract was initially bid for two years with the provision for a one-year extension.

The Engineering Department and the Contractor, Ferguson Electric Service Co., Inc., agree that a one-year extension of the current contract at the same terms and conditions would be mutually beneficial for both parties. The Contractor's interest in extending the current contract is expressed in the attached letter dated January 12, 2022. Ferguson Electric Service Co., Inc. has proven to be a highly capable and reliable vendor.

Based on this information it is recommended that the Authority exercise the one-year extension.

This contract is utilized to support the Authority's maintenance efforts related to the water treatment plants, pumps stations and the Service Center.

The waiver by the OWNER of any breach or violation of any term, covenant, or condition of this Agreement or of any Law or Regulation shall not be deemed to be a waiver of any other term, covenant, condition, or Law or Regulation or of any subsequent breach or violation of the same or of any other term, covenant, condition, or Law or Regulation. The subsequent payment of any monies or fee by the OWNER which may become due hereunder shall not be deemed to be a waiver of any preceding breach or violation by CONTRACTOR of any term, covenant, condition of this Agreement or of any applicable Law or Regulation.

### 11.0 Grounds for Renewal of Contract

A. If the Erie County Water Authority and CONTRACTOR mutually agree to continue this Contract after the 31<sup>st</sup> day of May 2022, it shall be extended for the term of one (1) year on the same terms and conditions provided for herein. CONTRACTOR shall provide written notification to the Erie County Water Authority of the contract extension prior to the expiration of the initial term of this Contract.

WHEREAS, the Contract, executed on June 1, 2020, provides services until May 31, 2022; and

**WHEREAS,** in accordance with Section 00500, Article 10, paragraph 11.0 (Grounds for Renewal) of the Contract, the Contractor has provided the Authority with written notification to extend the terms of the Contract for an additional one-year term; and

**NOW, THEREFORE,** in consideration of mutual promises herein set forth, the parties agree to the following:

(1) The terms and conditions of the Contract shall continue in effect until May 31, 2023;

(2) This Amendment may be executed in counterparts, each of which is deemed an original, but all of which together are deemed to be one and the same agreement; and
